# **Privacy Policy**

Garaje Norte informs you about its Privacy Policy regarding the treatment and protection of personal data of users and clients that may be collected by browsing or contracting services through the website <a href="https://garagenorte.es">https://garagenorte.es</a>.

In this sense, Garaje Norte guarantees compliance with current regulations regarding the protection of personal data, reflected in Organic Law 3/2018, of December 5, on the Protection of Personal Data and Guarantee of Digital Rights (LOPD GDD). It also complies with Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 regarding the protection of natural persons (GDPR).

### Obtaining personal data

### **Your Rights**

You have the right to effective judicial protection and to file a claim with the supervisory authority, in this case, the Spanish Data Protection Agency, if you consider that the processing of personal data that concerns you infringes the Regulation.

### Purpose of personal data processing

By filling out and sending the contact form on the website you are providing personal information for which the Owner is responsible. This information may include personal data such as your IP address, first and last name, physical address, email address, telephone number, etc. By providing this information, you give your consent for your information to be collected, used, managed and stored by Garaje Norte, as indicated in the Legal Notice and in this Privacy Policy.

The personal data and the purpose of processing by the Owner is different depending on the information capture system:

Contact Form. The Owner requests personal data which may include: Name and surname, email address, telephone number, etc. in order to respond to your queries. For example, the Owner uses this data to respond to your messages, doubts, complaints, comments or concerns that you may have regarding the information included on the Website or the services provided, as well as any other query you may have and that is not is subject to the conditions of the website.

There are other purposes for which the Owner processes your personal data:
